### Broker and Agent Compensation

AIG Australia Limited ('AIG Australia') values the role of insurance brokers and agents in advising and consulting with insurance buyers, and generally remunerates them in recognition of their participation in the purchasing process.

### Commissions

AIG Australia may remunerate insurance brokers and agents through commissions of either a specific dollar amount or a percentage of premium set at the time of each purchase, renewal, placement or servicing of a particular insurance policy. From time to time, AIG Australia may enter into agreements with brokers to provide additional commission not contingent in nature. All such payments are subject to legal, compliance and business management controls administered by AIG Australia.

### Contingent Compensation

From time to time, AIG Australia may provide compensation contingent on factors such as the overall profitability of the policies placed by an agent of AIG Australia. All such payments are subject to legal, compliance and business management controls administered by AIG Australia.

### Other Remuneration

AIG Australia may also enter into agreements for business facilitation and other strategic services in exchange for a fee including services outside of specific insurance transactions. AIG Australia may also provide remuneration for the advertising, distribution, marketing or purchase of insurance products or services through third-party channels. These arrangements may include compensation contingent on factors such as the overall profitability of the policies.
